Each parent has 24 weeks of leave after the birth of the child. Together, the parents have 48 weeks of leave with maternity/paternity allowance after the birth.

If the child's father/co-mother is employed, he/she can transfer a total of up to 13 weeks to you. I.e., you can take a total of up to 37 weeks of leave.

If the child's father/co-mother is self-employed or a student, he/she can transfer up to 22 weeks to you, which means that you can take a total of up to 46 weeks of leave.

As an employee, you can transfer up to 13 weeks to the father/co-mother.

The dates given below will be adjusted based on the actual date of birth.

11 weeks of leave are reserved for you and will lapse if you do not take them. The reserved leave must be taken before the child turns one year old.
